

14. वह केविसं. के स्थानांतरण दिशानिर्देशों के अनुसार अथवा आरंभिक नियुक्ति के तीन वर्षों तक स्थानांतरण हेतु अनुरोध नहीं करेंगी / करेंगे।

15. उन्हें पश्चिम ज़ोन आबंटित किया गया है।

16. पदस्थ कार्मिक को उत्तरवर्ती पदोन्नति हेतु मान्यता प्राप्त विश्वविद्यालय से शैक्षणिक एवं प्रोफेशनल उपाधि लागू नियमों और विनियमों के अनुसार अर्जित करनी होगी।


